## Notification regarding Semester-II Examinations, 2020

This is for information of all concerned that M.A. Semester-II Examinations, 2020 for eligible Students (academic session 2019-20) of PG academic of programme of the departments of Bengali, English, Sanskrit under the Faculty of Arts, and Rabindra Sangeet, Vocal Music under the Faculty of Fine Arts of the University will be conducted, on the basis of the UGC Guidelines on Examinations and Academic Calendar in view of COVID-19 Pandemic [vide D.O. NO. F1-1/2020 (Secy), dated 29th April, 2020 and vide D.O. NO. F1-1/2020 (Secy), dated 6th July, 2020], the verdict of Hon'ble Supreme Court dated August 28, 2020 and the latest UGC guide lines on academic calendar for Under Graduate and Post Gradate intermediate even semester students of the University for the session 2019-20 in view of COVID-19 Pandemic [vide D.O. NO. F1-1/2021 (Secy), dated 16th July, 2021 issued in this matter. University shall strictly abide by the Guidelines issued by the University Grants Commission (UGC) regarding modalities of examinations and spirit in the best interest of students maintaining the sanctity of examination.

Detailed modalities of M.A. Semester-II Examinations, 2020 for the eligible Students of PG academic programmes of all departments under the Faculties of Arts and Fine Arts of the University are mentioned below:

- 1. M.A. Semester-II Examinations, 2020 for PG academic programmes of above said subjects under the Faculties of Arts and Fine Arts of the University will be conducted by composite of 50% marks for each course on the basis of the Internal Assessment (IA) and the remaining 50% marks for each course can be awarded on the basis of performance in previous semester only. In the situations where previous semester marks are not available, 100% evaluation for each course may be done on the basis of Internal Assessment (IA).
- 2. Full marks of Internal Assessment (IA) for all the courses will be 25 marks under the Faculties of Arts and Fine Arts of the University.

3. However, this above-mentioned provision shall be applicable as a one-time measure as per UGC guidelines.

4. All such examinees under the Faculties of Arts and Fine Arts of the University would not

require to undergo any online Examination Form fill up.

5. Examination Fees of M.A. Semester-II Examinations, 2020 will be collected during Admission

in M.A. Semester-III.

6. Admission in M.A. Semester-III for the students of academic session 2019-20, who have also

submitted their internal assessment for M.A. Semester-II Examination 2020, will be done

shortly. Subsequent notification will be given in the website of RBU, CDOE.

7. If a candidate appeared in the process of Internal Assessment in a course of the academic

programme but failed in that course, then his/her Internal Assessment marks will be carried forward

and whenever he/she appears in that course in near future, this 50% IA marks will be converted into

20% IA marks on pro-rata basis.

8. If a candidate is unable to get his/her Internal Assessment done in each course in due time, then

his/her candidature will be cancelled.
